Pawan Hans Inaugurates its New Corporate office “PAWAN HANS TOWER”

Pawan Hans Helicopters Ltd. (A Govt. of India Enterprise) under Ministry of Civil Aviation has made its Corporate Office PAWAN HANS TOWER at C-14, Sector-1, Noida. The Office was inaugurated by Shri Praful Patelji the Hon'ble Minister of Civil Aviation at a gala function held on 6/5/2010 at PHHL NOIDA Office. Shri R.K. Tyagi, CMD Pawan Hans welcomed the esteemed guests.

Shri Satbir Singh Gurjar MLA also graced the occasion. The dignitaries' included Shri M. Madhavan Nambiar, Secretary (CA), Dr. Syed Nasim Ahmed Zaidi, DGCA, Shri Rohit Nandan, Joint Secretary, MOCA and Shri Sudhir Vasudeva Director offshore ONGC. The event was also marked by the presence other senior officials of the Industry, PSUs and MoCA. The state of the art building has eight floors and the total covered area is 37140 sqft. The office is spread in half acre of land.

On this occasion the Hon'ble Minister praised Pawan Hans for its achievements and having a new office. He also wished the Organisation huge success in times to come. The Hon'ble Minister stated that Pawan Hans should become the Flag Bearer of the Helicopter Industry in India with a fleet of atleast 100 helicopters and other PSUs should take cue from Pawan Hans seeing their growth path. This is another feather added in the achievement of Pawan Hans.

This task was achieved under the inspiration of Hon'ble Minister of Civil Aviation and other senior officials of Ministry of Civil Aviation. PHHL has witnessed significant improvement in over all performance under all parameters during the period 2006-07 to 2008-09. Fleet serviceability increased from 66% to 81% resulting in highest ever deployment & utilization of helicopters, leading to growth in operating revenue. The operating profit increased from Rs. 2.78 crores in 2006-07 to Rs. 6.21 crores in 2007-08 and to Rs. 20.30 crores in 2008-09. In the financial year 2009-10 the growth story continues with increase in Fleet serviceability to 83.2% and Operating Profit already touching Rs.34.00 crores.

2. One Bell 407 helicopter has been provided to M/S Himalayan Healing Touch w.e.f. 16.03.2010 for services during Kumbh Mela 2010.
3. Government has accorded sanction for project for Creation of Heliport at Rohini at an estimated cost of Rs.64.00 Crores and funds amounting to Rs. 15.00 crores has been received by PHHL.
4. Government has accorded sanction for project for development of Helicopter Training Academy and Heliport at Hadapsar Gliding Centre,Pune at an estimated cost of Rs.14.60 Crores and sanction received for funding of Rs.10.00 Crores from DGCA.
5. MOU has been signed with NTPC for providing a new Dauphin AS365N3 helicopter on wet leasing basis for a period of 10 years with 100% financing by NTPC, the acquisition cost of the helicopter and its initial inventories with interest @6% p.a. on reducing balance basis.
6. An Addendum has been signed with Govt. of Arunachal Pradesh for continuation of helicopter services by MI-172 for a period of three months i.e. upto 30th June, 2010.
