- (iii) The instruments will be returned with calibration certificate duly signed by trained technical person to meet Air Safety Civil Aviation Requirements.
- (iv) The lowest successful bidder meeting the basic tender criteria will be awarded the contract.
- (v) The agency should be ready to sign the contract with our standard terms and condition for one year (Extendable another one year).

SCOPE OF WORK:

- (i) The instruments received will be inspected and carry out necessary calibration.
- (ii) The instruments if found faulty sent for repair will be inspected and inspection report will be submitted with repair quotation.
- (iii) As per the approval repair will be carried out and certified by the trained technical person.
- (iv) The instruments will be delivered with valid calibration certificate.
- (v) The agency will deliver the instruments to PHL store, New Delhi basis after necessary repair/calibration at their own freight charges and instruments will be dispatched from PHL to Repair agency's location freight will be borne by PHL.
- (vi) The agency will attend the calls of our all bases, if any assistance needed during the use and operation of the instruments without any charges for minor malfunction.
- (vii) If any parts are to be replaced then part cost should be reasonable and prior approval from PHL should be obtained for replacement of the same.

TERMS AND CONDITIONS:-

- It is requested to forward quotations for the services required for the Alcosensor instruments in a sealed envelope indicating thier charges, Delivery Schedule, Validity of Quotation, payment Terms etc. on or before due date and due time. <u>Quotation should be submitted as per the above mentioned format only, failing which the quotation</u> <u>will not be considered.</u>

- **3.** The EMD will be forfeited, if the tenderer withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender. If the successful tenderer fails to furnish the required performance security within the specified period mentioned in clause no.3, your EMD will be forfeited.

- 4. The firm should require submitting a Performance Guarantee of 10% of the value of the contract. Performance Security may be furnished in the form of Bank Guarantee from a schedule commercial bank Performance Security is to be furnished by a specified date i.e. within 21 days on awarding the contract from order date from a schedule commercial bank which should be valid for more than 60 days over and above the contract period or completion of all contractual obligations of the supplier, including warranty obligations. The Performance guarantee will be forfeited in the event of a breach of contract by supplier, in terms of the relevant contract. Confirmation regarding acceptance of Performance Guarantee clause should be dearly <u>mentioned in your quotation otherwise your quotation will be rejected</u>.
- 5. Quotation must be firm and should be Valid for a minimum period of 60 Days from the Date of Opening.

6. a) If supplier offers quote on High Seas Sales Basis, then the responsibility of payment of additional 2% customs duty/GST/other Govt. levies and duties if any, except normal custom duty should be payable by the seller. (the customs add 2% additional customs duty on assessable value of items declared in bill of entry (BOE) due to high seas sales).

b) In case, Govt. of India discontinues import of goods on high seas sales, then no quote will be acceptable on high seas sales. - 8. The quantities mentioned in the Tender Notice are and shall be deemed to be only approximate and will not be in any manner, whatsoever is binding on PHL.
- 9. Wherever Tenderers have entered into the Rate contract with DGS & D, they shall indicate the same in their

tender. They shall also certify that the rates quoted are the same as are applicable on the rate contract finalized by the DGS &D.

- **10.** Quotation should be sent through sealed envelope only. Quotation received by mail, Fax or E-mail will not be considered.
- **11.** Liquidated Damages -Time and date of delivery of the stores shall be the essence of the Contract.

Should the contractor fail to deliver the stores within the stipulated period for such delivery or dispatch the purchaser shall be entitled to withhold payment until the whole off the stores have been supplied. After expiry of delivery date, LD will be recovered @ 0.5% (half percent) of the price of any stores which the contractor has failed to deliver or dispatch aforesaid for each and every week or part of a week subject to maximum 10% of the contract value.

- **12.** SSI Registered with NSIC/MSME shall be exempted from, payment of earnest money/security deposit Tender Fee. Tenderers seeking exemption should endose a photocopy of valid registration certificate with NSIC/MSME.
- **13.** The quotation has to be submitted keeping in mind our standard payment terms, i.e. after Receipt and Acceptance of the instruments after necessary calibration and repairs at our stores within 30 days.
- **14.** The quotation should be submitted on your Company's letter head only as per our format or quotation from Bidder's format shall not be applicable. Quotation should be in Indian Rupees only.
