1. 2. **Delivery should be immediate from the date of issuing the confirmed Purchased Order.**
3. An amount Rs.6000.00 (Rupees Six Thousand only) as EMD favouring 'PAWAN HANS LIMITED" should accompany the tender by A/C Payee demand draft drawn on any Commercial Bank payable at New Delhi should be submitted along with the tender or through make online payment through RTGS/NEFT and attach the payment details.

4. **SSI Registered with NSIC/MSME shall be exempted from payment of earnest money/security deposit Tender Fee. Tenderer seeking exemption should enclose a photocopy of valid registration certificate with NSIC/MSME.**
5. Quotation must be firm and should be Valid for a minimum period of 30 Days from the Date of Opening.
6. **Delivery of the goods will be on door delivery basis at our Rohini Heliport Address.**
7. GST Registration Number must be indicated on your quotation along with PAN copy.
8. The quantities mentioned in the Tender Notice are and shall be deemed to be only approximate and will not be in any manner, whatsoever be binding on PHL
9. Wherever Tenderer has quoted the Rate contract with DG S & D, they shall indicate the same in their tender. They shall also certify that the rates quoted are the same as are applicable on the rate contract finalized by the DGS & D.

**10. Quotation should be sent through sealed envelope only.** Quotation received by mail, Fax or E-mail will not be considered.

**11. Liquidated Damages** - Time and date of delivery of the stores shall be the essence of the Contract. The contractor fails to deliver the stores within the stipulated period for such delivery or dispatch the purchaser shall be entitled to withhold payment until the whole of the stores have been supplied. After expiry of delivery date, LD will be recovered @ 0.5% (half percent) of the price of any stores which the contractor has failed to deliver or dispatch aforesaid for each and every week or part of a week subject to maximum 10% of the contract value.

**12.** The quotation has to be submitted keeping in mind our standard payment terms, i.e. **After Receipt and Acceptance of item/s at our stores within 30 days.**

**13.** Printed Terms and Conditions on letter heads or quotation form of tenderer shall not be applicable. Quotation should be in Indian Rupees.

**14. ARBITRATION:**

(i) If any dispute(s) or difference(s) of any kind whatsoever arise between the Contractor and PHL, both the Parties hereto shall negotiate with a view to its amicable resolution and settlement through a committee appointed by CMD, PHL.

(ii) In the event, no amicable resolution or settlement is reached between the parties within 15 days after receipt of notice by one party, then the disputes or differences are detailed above shall be referred to and settled by the Sole Arbitrator to be appointed by CMD(PHL).

(iii) Notwithstanding the existence or any dispute or differences and/or reference for the arbitration, the Contractor shall proceed with and continue without hindrance the performance of the work under the contract with due diligence and expedition in a professional manner and the payment due to the Contractor shall not be withheld on account of such difference of arbitration proceedings unless such payment is a subject matter of the arbitration.

(iv) The arbitration proceedings shall be in accordance with the prevailing Arbitration and Conciliation Act, 1996 and laws of India as amended or enacted from time to time.

(v) The venue of the arbitration shall be New Delhi, India as PHL Registered Office is located and managed, there from. The fee and other charges of Arbitrator shall be determined by the arbitrator in terms of the Act and shall be shared equally between the parties.

(vi) The Arbitrator will be given the speaking and the reasoned Award. The parties will not be entitled to any pending interest during arbitration proceedings.

**15.**PHL Reserves the right to reject all (or) any of the tenders or to accept the tender either in full or in part or to split up the contract without assigning any reason.
