TERMS AND CONDITIONS :

1. It is requested to forward quotation for above item in a sealed envelope indicating Price, Delivery Schedule, Validity of Quotation, payment Terms etc. on or before due date and due time. **Quotation should be submitted in above mentioned format only, failing which the quotation will not be considered.**
2. An amount Rs.8000.00 (Eight Thousand only) as EMD favouring 'PAWAN HANS LIMITED" should accompany the tender by A/C Payee demand draft drawn on any Commercial Bank payable at New Delhi should be submitted along with the tender. **Quotation without Earnest Money Deposit will be rejected.**

The EMD will be forfeited, if the tenderer withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender. An unsuccessful bidders EMD amount will be refunded within 15 days from the date of opening of the quotes. Further the successful bidder EMD amount will be adjusted as a performance guarantee & the same will be refunded after delivering the Barrels in good condition.

ARBITRATION:

- 2.1 If any dispute(s) or difference(s) of any kind whatsoever arise between the Contractor and PHL, both the Parties hereto shall negotiate with a view to its amicable resolution and settlement through a committee appointed by CMD, PHL.
 - 2.2 In the event, no amicable resolution or settlement is reached between the parties within 15 days after receipt of notice by one party, then the disputes or differences are detailed above shall be referred to and settled by the Sole Arbitrator to be appointed by CMD(PHL).
 - 2.3 Notwithstanding the existence or any dispute or differences and/or reference for the arbitration, the Contractor shall proceed with and continue without hindrance the performance of the work under the contract with due diligence and expedition in a professional manner and the payment due to the Contractor shall not be withheld on account of such difference of arbitration proceedings unless such payment is a subject matter of the arbitration.
 - 2.4 The arbitration proceedings shall be in accordance with the prevailing Arbitration and Conciliation Act, 1996 and laws of India as amended or enacted from time to time.
 - 2.5 The venue of the arbitration shall be New Delhi, India as PHL Registered Office is located and managed, there from. The fee and other charges of Arbitrator shall be determined by the arbitrator in terms of the Act and shall be shared equally between the parties.
 - 2.6 The Arbitrator will be given the speaking and the reasoned Award. The parties will not be entitled to any pending interest during arbitration proceedings.
3. Quotation must be firm and should be Valid for a minimum period of 60 Days from the Date of Opening.
 4. **Delivery of our goods will be on door delivery basis at our Rohini Heliport Address.**
 5. GST Registration Number may please be indicated on your quotation along with PAN copy.
 6. The quantities mentioned in the Tender Notice are and shall be deemed to be only approximate and will not be in any manner, whatsoever be binding on PHL
 7. Wherever Tenderers have quoted the Rate contract with DG S & D, they shall indicate the same in their tender. They shall also certify that the rates quoted are the same as are applicable on the rate contract finalized by the DGS & D.
 8. **Quotation should be sent through sealed envelope only.** Quotation received by mail, Fax or E-mail will not be considered.
 9. **Liquidated Damages** - Time and date of delivery of the stores shall be the essence of the Contract. The contractor fail to deliver the stores within the stipulated period for such delivery or dispatch the purchaser shall be entitled to with hold payment until the whole off the stores have been supplied. After expiry of delivery date, LD will be recovered @ 0.5% (half percent) of the price of any stores which the contractor has failed to deliver or dispatch aforesaid for each and every week or part of a week subject to maximum 10% of the contract value.
 10. SSI Registered with NSIC/MSME shall be exempted from payment of earnest money/security deposit Tender Fee. Tenderers seeking exemption should enclose a photocopy of valid registration certificate with NSIC/MSME.
 11. The quotation has to be submitted keeping in mind our standard payment terms, i.e. After Receipt and Acceptance of item/s at our stores within 30 days.
 12. Printed Terms and Conditions on letter heads or quotation form of tenderers shall not be applicable. Quotation should be in Indian Rupees.
