3. The agency will submit the bills in two sets with PHL GST No. 27AAACP1561A1ZZ alongwith supporting documents i.e. calibration certificate in duplicate i.e original + duplicate copy.
4. The agency will submit bill with clearly mentioning the part no., description and serial no. of the equipment and calibration certificate number.

- a) The bidders having office within 300 km perimeter of Mumbai
  - b) The lowest bidder L-1 for each item will be awarded the contract .
  - c) The supplier is ready to enter into an AMC for two years as per our standard Terms and conditions and extendable for one year on discreation by PHL. and satisfactory performance.
  - d) The agency should have NABL accreditation and have to confirm the same against each item and submit calibration certificate of Master calibrator.
  - e) The agency must be ready to collect and deliver the equipments to PHL store and include all the charges of transportation etc. in the quotation and no extra charges will be paid.
3. You are required to submit a Performance Guarantee of 3% of the value of the contract. Performance Security may be furnished in the form of an Bank Guarantee from a schedule commercial bank Performance Security is to be furnished by a specified date i.e. within 21 days on awarding the contract from order date from a schedule commercial bank which should be valid for more than 60 days over and above the contract period or completion of all contractual obligations of the supplier, including warranty obligations. The Performance guarantee will be forfeited in the event of a breach of contract by supplier, in terms of the relevant contract.   4. Quotation must be firm and should be Valid for a minimum period of 60 Days from the Date of Opening.

6. GST Registration Number may please be indicated on your quotation alongwith PAN copy.
