11.0) DEFAULT IN LIFTING:

- 11.1) In case of any default in lifting of the material by the buyer(s) within the time limits, of the e-Auction, the un-lifted material may be lifted within 6 weeks from the due date, subject to payment of ground rent for the period of delay beyond the specified due date. Ground rent will be payable @ 1% per week plus GST or part thereof on the value of the un-lifted quantity and such charges will be deposited by the buyer before the material/items are lifted. 12.0) STATUTORY PAYMENTS:

The rate of GST/Income Tax or any other statutory Duty/Tax/Levy/Charge etc.will be applicable and payable by the Buyer as prevailing on the date of actual physical delivery of materials. The rates of Duties and Taxes displayed on the e-Auction Website are only indicative and based on the rates prevailing before the commencement of the e-Auction.

13.0) PERIOD OF CONTRACT:

Upto the validity period of the Delivery Order/Release Order issued by MSTC/PRINCIPAL or upto the extended period of validity of the Delivery Order/Release Order in case the Delivery period is extended by the PRINCIPAL at his sole discretion as the case may be.

14.0) SALE OF VEHICLES:

- However in all the above cases, the PRINCIPAL will have the sole discretion to decide whether they would sell the Vehicle for Scrapping or otherwise and no complaint/representation will be entertained from the Bidder in this regard.
- (c) Vehicles are being sold on as is where is basis: it is the responsibility of the bidder to ascertain the present condition of the vehicles in all respects. The successful bidder shall make necessary arrangements for obtaining necessary clearances from the concerned RTO authorities regarding name transfer/obtaining clearance certificate/registration cancellation etc by paying necessary charges/taxes/insurances etc. if any (present or previous) to the concerned authorities. - 18.0) The Rate must be quoted exclusive of all kinds of Duties and Taxes like Excise Duty, GST/Sales tax, TCS etc. These will be charged extra as applicable. Any variation in Excise Duty, GST, VAT/Sales tax or in any other kind of applicable tax and any fresh statutory levies at the time of delivery will be borne by the buyers. C form will NOT be accepted toward sales tax for interstate sale.
- 19.0) The quantities indicated against the lot are purely indicative. The quantity in actual may turn out to be more or less than the estimated quantity. In the event of quantity turning out to be more than the estimated quantity the buyer has to lift the allotted quantity. In the event of actual quantity turning out to be less than the estimated quantity, the buyer shall not be entitled to claim any damages, loss of interest or compensation on this count. The material as offered has to be lifted by the buyer.
- 20) The Bidders/ customers' workmen shall have to abide by the rules & regulation including safety & security regulation of the relevant statutory acts. Entry inside the works / stores should only be against Gate pass for the men and equipment for which purchaser will have to apply well in advance before lifting commences.
- 21) The Buyer will employ his own labour and means; at his own cost and risk for removal/collection/shifting of scrap as per schedules and payment of wages/compensation to the labourers will be the sole responsibility of the buyer. The purchaser shall ensure that his workmen do not loiter around within the stores area of the factory areas. They shall not touch any material except those materials shown to them. If any of his workmen is even found violating these restrictions, the purchaser shall be responsible for making good the loss to the owners on which their decision shall be final and binding.
