5.0 BID SECURITY/ EMD

5.1 All bids must be accompanied by a bid security amount of Rs. **12,390.00**.

5.2 EMD shall be in favour of 'PAWAN HANS LIMITED' and shall be acceptable in the form of Crossed Demand Draft (Payable at Mumbai (MH) or Bank Guarantees (B.G.) in the prescribed pro-forma from Scheduled Commercial banks in India/ Indian Branch of Foreign Bank. The B.G. shall be valid for a period of 6 months (4 + 2) from the final due date of submission of Bid.

5.3 Following categories of bidders shall be exempted from paying Earnest Money Deposit (EMD):

- i) Units registered with National Small Industries Corporation (NSIC).
- ii) Units falling under Micro & Small Enterprises (MSEs) category as defined under the MSMED Act 2006. The above are subject to the fulfilling of under mentioned conditions:
 - a) Units should be registered with National Small Scale Industrial Corporation Limited (NSIC) or with any of the Authorities specified under the Public Procurement Policy for MSE's (DIC / KVIB / Coir Board / NSIC / Directorate of Handicrafts and Handloom or any other body specified by Ministry of MSME).

 - c) Self-attested copy of valid relevant registration certificate should be submitted in support.
 - d) Registration with DGS&D will not entitle a Tenderer to claim above exemption.

5.4 MSEs (Micro & Small Enterprises) are exempted from submission of EMD in accordance with the provisions of PPP-2012. The Government Departments/PSUs are also exempted from the payment of EMD. However, Traders/Dealers/ Distributors /Stockiest /Wholesaler are not entitled for exemption of

- 5.5 Unsuccessful Bidder's EMD will be discharged/ returned as promptly as possible, but not later than 'thirty [30] days' after finalization of tendering process.
- 5.6 The successful Bidder's EMD will be discharged upon the Bidder's acknowledging the 'Award' and signing the 'Agreement' (if applicable) and furnishing the 'Performance Bank Guarantee (PBG)/ Security Deposit'.
- 5.7 Notwithstanding anything contained herein, the EMD may also be forfeited in any of the following cases:
- e) If a Bidder withdraws his Bid during the 'Period of Bid Validity'
 - f) If a Bidder has indulged in corrupt/fraudulent /collusive/coercive practice
 - g) If the Bidder modifies Bid during the period of bid validity (after Due Date and Time for Bid Submission).

- 6.1 Price Evaluation will be carried out on Overall SOR lowest cost basis.
- 6.2 Total value for evaluation will be considered inclusive of GST in the prize bid.

7.0 AWARD METHODOLOGY

- 7.1 PHL will award the contract (100% scope of work) to the successful Bidder whose bid has been determined to be substantially responsive and has been determined to be the lowest evaluated bid on Overall lowest cost basis.
- 7.2 In case if there is tie in L-1 the bidder/s than PHL will ask bidders to provide the discounted offer and bidder provided maximum discount shall be declared as L1.
- 7.3 PHL reserves the rights to provide the sample from L1 bidder for testing without any additional cost to PHL (If required in supply case). After approval of the sample from concerned user department, the contract shall be awarded to L1 bidder.
- 7.4 In case sample from L1 bidder get rejected, then PHL will ask other bidder L2, L3 rank wise for providing the sample, accordingly after approval from the concerned department, order shall be placed to next successful bidder

8.0 PERFORMANCE GUARANTEE

- 8.1 The bidder is required to submit a Performance Guarantee of 3% of the value of the contract. (or as per the latest guidelines/circular published by the concern Ministry) Performance Security May be furnished in the form of a Bank Guarantee from a schedule commer

- 9.1 Time and date of delivery of the stores shall be the essence of the Contract. - 16.1 Notwithstanding any other court or courts having jurisdiction to decide the question(s) forming the subject matter of the reference if the same had been the subject matter of a suit, any and all actions and proceedings arising out of or related to the contract (including any arbitration in terms thereof) shall lie only in the court of competent civil jurisdiction in this behalf at Mumbai Court and only the said Court shall have jurisdiction to entertain and try any such action and / or proceedings to the exclusion of all other courts.

17.0 FORCE MAJEURE:

- 17.1 If, at any time, during the continuance of the contract the performance in whole or in part by either party or any obligation under this contract is prevented or delayed by reason of hostility, acts of any public enemy, civil commotion, sabotage, fires, floods, explosion, epidemics, quarantine restrictions, strikes, lockouts, or act of God then neither party shall have any claim for damages against the other in respect of such non-performance and delay in performance provided notice of the happening of any such event is given by the affected party to the other within 48 hours from the occurrence thereof. If such event continues beyond a reasonable period (which shall be determined by the Jt. General Manager (Materials), WR Pawan Hans Ltd, Mumbai in each case based on merits) Pawan Hans Ltd shall have the right to re-allot the work to some other agency or to terminate the contract as may be deemed appropriate by Pawan Hans Ltd.

18.0 ARBITRATION:

- 18.1 Except as otherwise expressly provided, all questions and disputes relating to the contract or as to any other question, claim, right or things whatsoever, in any way arising out of or relating to the contract or the execution or failure to execute the same during stipulated/extended period or after



completion/abandonment thereof shall be referred to the sole arbitration the person appointed by a member of Pawan Hans Ltd, at the time of dispute. The transporter agency will have no objection to any such appointment on the ground that the arbitrator so appointed is a Pawan Hans Ltd, employee that he had to deal with the matter to which the contract relates and that in the course of his duties as Pawan Hans Ltd, employee he had expressed views on all or any of the matter in dispute or difference. The arbitrator to whom the matter is originally referred to being transferred or vacating his office or being unable to act for any reasons, the member of Pawan Hans Ltd, shall appoint another person to act as arbitrator. Such person shall be entitled to proceed with reference from the stage at which it was left by his predecessor. Subject as aforesaid the provisions of the Indian Arbitration Act, 1940 or any statutory modification or re-actment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings under this clause. The venue or arbitration shall be at Mumbai. The contract shall continue to be operated during the currency of the arbitration proceedings unless otherwise directed in writing by the Pawan Hans Ltd. In case of any dispute on account of interpretation of any word, sentence or clause of this notice, the decision of Jt. General Manager (Mats), WR Pawan Hans Ltd, Mumbai shall be final and binding on the transport agency and shall not be opened to arbitration.


